

## FMVSS 110 Compliance Information

All dealers must determine if the weight they have added in the form of all options or accessories, when added to the weight of all Port/Dealer installed options or accessories, exceeds the lesser of 1.5% of GVWR or 100 lbs. If the additional weight does exceed the lesser of the indicated thresholds, a "Load Carrying Capacity Reduced" label must be installed. A black, fine-point, indelible marker must be used to write by hand onto the label, the reduced carrying capacity in kilograms or pounds, which is the total weight of all added options and accessories.

**Warning!** Ensure that the All Weather Floor Mats are securely attached to the vehicle's floor mat anchor(s) before driving the vehicle. This keeps the All Weather Floor Mats from sliding forward. If the All Weather Floor Mat slips and interferes with the movement of the pedals during driving, it may cause an accident.

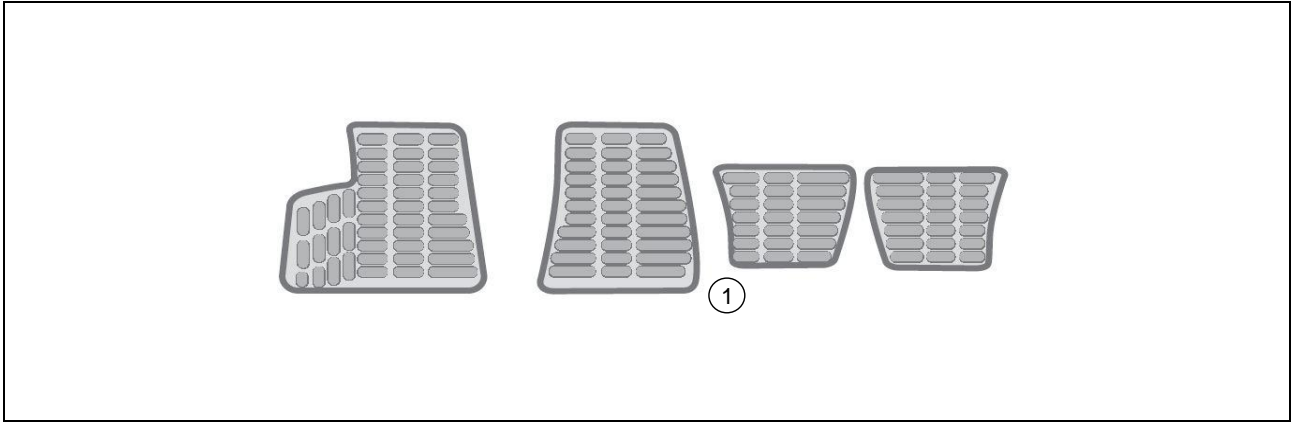
Do not put an additional Floor Mat on top of the anchored All Weather Floor Mat, otherwise the additional mat may slide forward and interfere with the movement of the pedals.

## Notes to the installer:

- 1 Dealer must clearly advise customer of installation method.
- 2 Before installing, verify and identify all parts.
- 3 Remove vinyl factory covering from carpeted areas before installation.
- 4 Sliding driver and passenger seats to furthest rearward position provides better access to install front mats properly.
- 5 When removing mats, be sure to hold grommet and mat at the same time, then pull forward.







N O T E	<p>A. If present, locate the Hang Tab on each All Weather Floor Mat.          B. Carefully remove the Hang Tab from each All Weather Floor Mat as shown.          C. Discard the removed Hang Tabs.</p>

N O T E	<p>A. Install the driver side floor mat by aligning the plastic grommet(s) with the retention hook(s) protruding from the vehicle floor. If necessary, rotate the grommet(s) in the mat to align it with the retention hook.</p>

NOTE	<p><b>NOTE:</b> Some vehicles may not have rear retention hook(s) protruding from the vehicle floor.</p> <p>A. Place the All Weather Floor Mat Grommet(s) over the vehicle Retention Hook(s) and push down to lock into place.</p> <p>B. Repeat steps 2 - 3 to install the passenger side All Weather Floor Mat.</p> <p>C. If rear mats are included in the set, repeat steps 2 - 3 to install the rear All Weather Floor Mat(s). Rear retention hooks are included on some models.</p>
